Publication of the *Economic History Review* rapidly enhanced the reputation of the Society worldwide and this internationalism remains strongly represented in the global distribution of membership and in the strong emphasis upon wide ranging and international topics in the *Review*.

Spectacular growth in membership up to the 1970s has been followed by a period of consolidation that has enabled the Society effectively to engage its resources to enhance research and teaching in the subject. This is done in a variety of ways but principally by providing training and financial support for new scholars, by encouraging and financing research workshops and networks, and by sponsoring and assisting key publications from research monographs to teaching packs. The *Economic History Review* is published quarterly. Each issue contains five or six major research articles reflecting the latest contributions to knowledge and to debates in economic and social history. Some volumes contain further comment and replies and a full list of publications relating to British economic and social history is published yearly in the November issue. Articles reviewing a wide ranging periodical literature and relating to distinct periods of British history appear annually in the February issue. The *Review* aims at broad coverage of themes relating to economic and social change, and associated intellectual, political and cultural developments, world wide from the medieval period to the twentieth century. It is the key publication for keeping abreast of the latest developments in the subject.

Some issues contain an essay under the heading *Surveys and Speculations* which allows for publication of broad ranging speculative and/or theoretical pieces. Other issues contain *Essays in Bibliography and Criticism* that are designed to bring readers up to date with the latest writings on a particular country or a research topic.

All issues contain numerous book reviews covering the latest publications in the field and written by a wide range of specialist historians.
